Track and Field Sports Specific Report: Adam Kedge

NMAA State Track Meet schedule is approved,; discussion of placement of 800 meters open and the 1600 meters Medley. The question will be voted on by membership. 800 Relay set up was discussed; in lanes versa cut in; State qualifying marks to be discussed in November. Also, discussions on high jump, false start, and how team sections are determined at state meet will be surveyed by member schools.
